1. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid

for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for % (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

PREQUALIFICATION CRITERIA

The bidders shall upload following pre-qualification documents along with their offer as per mentioned in PART-I of e-tender:

Pre-qualification Criteria:

1) Work Experience:

a) Vendor shall have experience in non-chromate industrial CW treatment with zinc as cathodic inhibitor and stabilized phosphate as anodic inhibitor on a formulation basis only.

and

b) Vendor should have experience in non-chromate industrial CW treatment for at least two years on continuous basis during last seven years at least at one site in treating the cooling tower with cooling water circulation flow of minimum 7200 m³/hr. Party shall have experience of handling the situations involving ammonia ingress in cooling water.

and

- c) Vendor shall have experience of treating the cooling tower with cooling water circulation flow of minimum 7200 m³/hr with a maximum corrosion rate of 1.5 mpy (one point five mills per year), measured on MS un-passivated coupons installed on return CW lines / headers on monthly basis for a period of one year.
- d) Vendor shall submit photo copies of work orders and user certificates for satisfactory and successful performance which shall include the following details for the experience quoted in a, b & c.

- i CW circulation flows (M³/Hr).

- ii. Details of the CW treatment chemistry.

- iii. Corrosion rates (mpy) guaranteed and achieved.

- iv. Duration of the program specifying periods of treatment.

Vendor shall give list of present users with the above details of on-going treatment including treatment period.

- e) Vendor shall have adequate up to date technology /equipment for cooling water performance monitoring including flow, temperature, corrosion rate measurement etc at site.

Vendors shall have experienced technician for above job.

- f) Party's shall submit purchase /Work Order satisfying point no. a,b & c in single Purchase/Work Order.

(Vendor shall submit the completion certificate / documents indicating work completion issued by end user, corresponding to the submitted work-orders).

- 2) Average annual financial turnover during the **last three years**, ending 31st March of the previous financial year (i.e. FY 2020-21, 2021-22 & 2022-23 OR FY 2021-22, 2022-23, 2023-24) should be **at least Rs. 6.66 Lakhs**.

*In case the date of constitution/incorporation of the bidder is less than three years old, the average annual financial turnover in respect of the completed financial years after the date of constitution shall be taken into account. In this case, the financial turnover during last financial year/ the average financial turnover during preceding two financial years should be **at least Rs. 6.66 Lakhs**.*

Bidders shall submit CA certificate / CA audited Profit & Loss accounts, Balance sheets etc. indicating the annual turnover figures, in support of the same. The financial documents has to be CA audited/issued with membership number, seal, signed and with UDIN.

- 3) Ownership of company with name, addresses and telephone nos. of proprietors/ partners/directors.

- 4) Copy of Partnership deed /proprietorship/ Memorandum and article of association and certificate of incorporation as the case may be.
- 5) All the bidders have to submit the **Net worth certificate** of last three financial years issued by CA with membership number, seal, signed and with U DIN or CA audited financial statements/balance sheets for each of the **last three financial years**.

The net worth should not be negative in the balance sheet of last financial year (i.e. net worth should not be negative on 'The Relevant Date').

AND

Net Worth of bidder should not have eroded by more than 30% (thirty percent) in the last three years, ending on 'The Relevant Date'. **It means the net worth of last financial year should not be less than 70% compared to the 3rd last financial year.**

In case the date of constitution/ incorporation of the bidder is less than 3 years old, the following will be applicable:

- ∅ The Net Worth in each of these years should not be negative.
- ∅ Net Worth in respect of the immediate previous financial year should not have eroded more than 30 per cent than that of its previously audited financial statement. In case the Bidder has completed financial statements of only preceding year, the clause of net worth erosion will not be applicable.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the [General Terms and Conditions/सामान्य नियम और शर्तें](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace.
