Scope of work:

- The service engineer shall provide supervisory assistance or Technical assistance to the RCF site engineer during any breakdown maintenance and trouble shooting.
- M/S. ABB shall depute their service engineer who is competent and familiar with the above systems as and when requisitioned by M/S. RCF during any breakdown or emergency.
- M/S. RCF shall arrange the shutdown of the GTG sets (If required) for carrying out the job safely.
- M/S. ABB shall arrange for the special instruments such as Storage Oscilloscope (CRO) for the job. M/S. RCF shall inform the requirement before deputation of the service engineer.
- When called the service engineer shall carry out the complete check of the system to the satisfaction of M/S. RCF so that the machine can be started safely.
- The service engineer shall be able to guide / provide the solution in the least possible time.
- M/S. ABB shall revert back with the root cause of the problem and also suggest the solution so that the problem of similar kind should not come up in the future.
- General purpose tools and tackles required for carrying out the work will be provided by RCF free of charge. Any special tools, software required for servicing or trouble shooting of the job shall be arranged by M/S. ABB.
- Unskilled and semiskilled labour required will be provided by RCF free of charge.
- RCF shall arrange for the regular spares. However party shall arrange any spares required for the successful execution of the job. In such case any part replaced during servicing / rectification will be paid extra at rates prevailing at the time of dispatch/replacement at Site.

Tenure of the contract:

The work order shall be valid for a period of TWO years.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.

14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
