Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service

provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

# THE PRE-QUALIFICATION CRITERIA FOR BIDDERS TO BE MENTIONED IN NIT SHALL BE AS FOLLOWS:

- Bidder shall have head office or branch office and workshop within the radiu s of 200 km from RCF Thal, Alibag. Bidder has to submit documentary eviden ce for address proof.
- 2. Bidder shall submit Work Order copies of successfully completed similar wo rks for control valve overhauling/reconditioning as per mentioned in scope of work, during last 7 years in large organizations like industrial complexes, refineries, fertilizers, petrochemicals, integrated steel plants etc. ending last day of month previous to the one in which applications are invited the completed/executed works should be either of the following:-

(Only completed work orders shall be considered for technical pregualification.)

i. Three similar completed/executed works each costing not less than the amount equal to Rs. 9,61,000/-each + GST,

#### OR

- ii. Two similar completed/executed works each costing not less than the amount equal to Rs. 12,01,000/-each + GST,
- iii. One similar completed/executed work costing not less than t he amount equal to Rs. 19,22,000/-each + GST.
- Performance/completion certificate/ minutes of meeting/ payment invoice/ any other document indicating completed work for above jobs from organization where work order was executed. Bidder shall submit self-attested copies of work orders as detailed above.
- Copy of partnership deed/proprietorship /Memorandum and article of associ ation, certificate of incorporation.
- 4. All the bidders have to submit the **Average annual financial turnover** of last three financial years (i.e. FY 2020-21, 2021-22, 2022-23 **OR** 2021-22, 2022-23, 2023-24) issued by CA with membership number, seal, signed and with UDIN or CA audited financial statements/ profit loss for each of the **last three financial years.**

Average annual financial turnover during the <u>last three years</u>, ending 31<sup>st</sup> March of the previous financial year (i.e. FY 2020-21, 2021-22, 2022-23 **OR** 2 021-22, 2022-23, 2023-24) should be **at least Rs. 7,21,000/-** In case the date of constitution/incorporation of the bidder is less than three years old, the average annual financial turnover in respect of the completed financial years after the date of constitution shall be taken into account. In this case, the financial turnover during last financial year/ the average financial turnover during preceding two financial years should be at least **Rs. 7,21,000**/.

5. All the bidders have to submit the **Net worth certificate** of last three fina

ncial years (i.e. FY 2020-21, 2021-22, 2022-23 **OR** 2021-22, 2022-23, 2023-24) issued by CA with membership number, seal, signed and with UDIN or CA audited financial statements/ balance sheets for each of the **last three financial years.** 

The net worth of the Bidder firm should not be negative on 'The Relevant Date'. It means the net worth of the Bidder should not be negative in the balance sheet of last financial year. AND

Net Worth of bidder should not have eroded by more than 30% (thirty percent) in the last three years, ending on 'The Relevant Date'. It means the net worth of last financial year should not be less than **70**% compared to the 3rd last financial year.

In case the date of constitution/ incorporation of the bidder is less than 3 years old, the following will be applicable:

- (i) The Net Worth in each of these years should not be negative.
- (ii) Net Worth in respect of the immediate previous financial year should not have eroded more than 30 per cent than that of it's previously audited financial statement. In case the Bidder has completed f inancial statements of only preceding year, the clause of net worth erosion will not be applicable.

# Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any

Category item bunched with it.

- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य</u> नियम और शर्तें, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
