# **Pre-qualification Criteria:**

## 1) Work experience:

All the bidders shall submit copies of work-orders with completion certificate, issued by their clients, for mechanical maintenance job done in fertilizers/chemical/Petrochemical industries /Power Plant/Heavy Water Plant operating in India. during the last seven years ending the last day of month previous to the one in which this subject tender is floated/issued and should be fulfilling, either of the following:

## Minimum value of work must be as follows:

Three similar completed works each costing not less than the amount equal to Rs.23.3 4 Lakhs. (excl.GST)

# OR

Two similar completed works each costing not less than the amount equal to Rs. 29.17 Lakhs. (excl.GST)

#### OR

One similar completed work each costing not less than the amount equal to Rs. 46.68 Lakhs. (Pwwwwexcl.GST)

(Bidders shall submit the completion certificate / documents indicating work completion issued by clients clearly, corresponding to the submitted work-orders).

2) Average annual financial turnover during the <u>last three years</u>, ending 31<sup>st</sup> March o f the previous financial year (i.e. FY 2021-22, 2022-23, 2023-24) should be at least R s. 17.50 Lakhs.

In case the date of constitution/incorporation of the bidder is less than three years old, the average annual financial turnover in respect of the completed financial years afte r the date of constitution shall be taken into account. In this case, the financial turnov er during last financial year/ the average financial turnover during preceding two financial years should **be at least Rs. 17.50 Lakhs.** 

Bidders shall submit CA certificate / CA audited Profit & Loss accounts, Balance sheets etc. indicating the annual turnover figures, in support of the same. The financial docu ments has to be CA audited/issued with membership number, seal, signed and with U DIN.

  <u>st three financial years</u>.

The net worth of the Bidder firm should not be negative on 'The Relevant Date'. It means the net worth of the Bidder should not be negative in the balance sheet of last financial year.

#### **AND**

Net Worth of bidder should not have eroded by more than 30% (thirty percent) in the last t hree years, ending on 'The Relevant Date'. It means the net worth of last financial year should not be less than **70%** compared to the 3rd last financial year.

In case the date of constitution/ incorporation of the bidder is less than 3 years old, the following will be applicable:

- Ø The Net Worth in each of these years should not be negative.
- Ø Net Worth in respect of the immediate previous financial year should not have erode d more than 30 per cent than that of it's previously audited financial statement. In c ase the Bidder has completed financial statements of only preceding year, the claus e of net worth erosion will not be applicable.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without

- specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
