RCF has issued GEM enquiry no. GEM/2024/B/5434435 dt. 26.09.2024 for the procurement of Aluminium Composite Panel Sheet at RCF Trombay Unit.

You have submitted your techno-commercial offer against the GEM enquiry no. GEM/2024/B/5434435 dt. 26.09.2024.

After techno-commercial scrutiny, your price bid has been opened. M/s Yashraj Enterprises are the lowest bidder and have quoted the total evaluated cost of Rs.865/-. Subsequently vide e-mail dated 17.01.2025, you have stated that "unfortunately you have mistakenly entered the rate as a per square foot price instead of the correct price. This mistake has resulted in a quoted price much lower than what is needed to complete the project". Further, you have also stated that it is not possible for you to work on the project at the quoted rate due to this error, which is not acceptable and considered as backing out from quoted price.
