## **SCOPE OF WORK**

### **ARC FOR METALLURGICAL TESTING & CHEMICAL ANALYSIS**

#### **Partys Scope:-**

1. Party shall collect samples from RCF, Thal site and deliver report to RCF.
2. Test pieces shall be tested for required parameters as per the instructions of RCF Engineers at your laboratory.
3. After receiving call from RCF, Party shall inform about the test sample size in advance so that sample can be prepared accordingly
4. Test samples shall be given by RCF in normal form as per size specified by party. Further machining or sample preparations shall be done by the contractor at no extra cost at contractor's Laboratory
5. The scope for chemical analysis includes testing of all elements including carbon.
6. The soft copy of report shall be submitted in four days for the parameters required through mail. And hard copy of the report shall be submitted within 15 days through speed post. The report shall also identify the ferrous sample to the corresponding ASTM / IS standards.
7. Any extra tests for micro - analysis or IGC tests shall also be done by the Party

upon request from RCF Engineer for which payment shall be done as per separate certified invoice.

8. Transport charges shall include sample collection charges as well as report submission charges within the stipulated period
9. The rates quoted shall be valid for a period of 2 years.

### **RCFs Scope:**

1. RCF shall arrange for sample as per specified size by party.
2. RCF will arrange for issuing of the material on Non-returnable basis.

**NOTE:** If terms mentioned in Annexure-II, Annexure-IIA of the tender document are contradicting with the terms and conditions mentioned in General Terms and Conditions Annexure-I & IA of the tender document, then terms and conditions mentioned in Annexure-II, Annexure-IIA shall prevail.

## **A. PREQUALIFICATION CRITERIA**

The bidders shall upload following pre-qualification documents along with their offer as per mentioned in PART-I of e-tender:

1. Party has to submit self-attested work order copies for metallurgical testing which shall include mechanical testing (Tensile, hardness etc.) or chemical analysis or any other similar testing job in Fertilizer/ refinery /power/ steel industry/Petrochemicals industries etc. The work order should be issued & executed during the last 7 years ending last day of month previous to the month in which application are invited/issued.
2. Proof of execution of submitted work order, which include any of the following
  - (i) Completion Certificate/ Customer Acceptance Certificate OR
  - (ii) GeM CRAC (Consignee Receipt and Acceptance Certificate) document OR
  - (iii) (a) Tax Invoice to the extent of the required Pre-Qualification value and  
(b) Proof of receipt of payment like bank statement for the above referred tax invoice OR
  - (iv) Any other document indicating work completion
3. Copy of partnership deed/proprietorship /Memorandum and article of association, certificate of incorporation.
4. Copy PAN Details, GST Registration details, PF Registration details and ESI C registration details.
5. Udyam / MSME registration certificate, if applicable.

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

**All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.**
