1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

2. Buyer Added Bid Specific Scope Of Work(SOW)

Text Clause(s)

- RCF has Farmers Training Centre at Thal, Tal. Alibag, Dist. Raigad (Maharashtra). FTC, F Thal shall organize **15-20 nos.** of 3 days duration farmers training programs each year during 2025-26 & 2026-27.
- Around **30-40** no. of farmers participate in each program. The scope of work consists of providing **Bus services** for passenger transportation of group of farmers (**30-40 no's**) participating training programs at FTC, Thal as per schedule enclosed with this NIT.
- The contractor shall have to provide **non-AC 40-45 seater** bus with tourist permit to RCF Thal, as per requirement on the basis of fixed charges per training programs of **thirty days** duration of FTC, RCF Thal, taking into consideration charges such as cost of tourist vehicle, registration, comprehensive insurance, RTO Tax, maintenance charges, wages of driver, cleaner, statutory payments, liveries, overhead etc.
- The vehicle offered shall be in sound condition and has to be registered as tourist vehicle with RTO authority of Maharashtra state.**
- Contractor shall provide vehicle with experienced driver, cleaner, uniforms as per rules and regulations of RTO.
- Contractor shall ensure that the tank of the vehicle is full and its capacity with diesel be

sending the vehicle on duty: In case of refilling after reporting on duty, **penalty of Rs. per incidence will be charged**. As and when the vehicles are under repairs, the repair will be at expense/cost of the transport contractor.

7. Contractor will make necessary arrangement to provide alternate tourist bus of the same latter model after giving letter in advance and getting alternative vehicle, approved by polling officer.
8. **The repairs should be completed at the earliest maximum within 15 days' time granted such maintenance.** In case the contractor is not in a position to provide same later make/model of same vehicle, permission may be given to provide bus model with same or higher cc of same fuel category at same rates applicable for type of vehicle provide by agencies to RCF Thal, however this will not bind on RCF.
9. In case of contractor fails to provide alternate arrangement, the entire travelling expenses will be at contractor cost and same will be recovered from his monthly running bills/ security deposit.
10. The vehicle should be road worthy in all respect for operation in accordance with Motor Vehicle Act and rules made there under by the state and existing laws as applicable from time to time. Contractor shall be responsible for the consequences whatever on account of a pse in this regards.
11. The contractor will hand over minimum Rs.1000/- (One thousand rupees) to the driver before reporting for duty to meet unforeseen emergency expenditure towards repairs or purchase of oil/fuel, parking expenses.
12. The contractor will have to ensure that his drivers attached to the vehicle abide by the Security Rules and Regulation of the RCF and the contractor will be responsible for any act of commission on the part of his drivers/employee. The contractor shall also ensure that his employee/ drivers behave properly with farmers and RCF officials. In case of misbehavior on the part of driver the contractor shall arrange for replacement of such drivers immediately without demur.
13. The drivers should not leave vehicle during duty hours without the permission of RCF Farmers training Centre officers.
14. The contractor shall obtain all license/permits at his cost, required for execution of his contract work, under relevant laws and shall maintain all such registers/records as required by such laws in force and will be coming into force from time to time and display such information and notice as are required. Any information required by RCF for discharges of obligations under such laws shall be promptly furnished by the contractor.
15. The contractor will be liable for all claims of damage, compensation or expenses payable as a result of any accident or injury or death sustained by workmen employed by him or claims of damage of third party or human life or damage to any property which is liable to pay under laws or order of govt.
16. The contractor will absolve RCF Ltd., from any claims of damage, compensation and he will be solely responsible for settlement of the same.
17. The contractor shall ensure that drivers deployed on the tourist vehicle shall have the following:

1. Valid tourist vehicle license
2. Do not report for duty under influence of alcohol or any narcotics.

18. Incase vehicle does not report on duty due to any problems as per the schedule time then the manager will be free to hire the vehicle from local market at the risk and cost of the contractor and recover the difference from the monthly bills of the contractor with penalty of Rs.500/-

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this they can raise their representation against the same by using the Representation window provided in the bid details in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and
- All operative provisions of the erstwhile Labour Laws until their complete substitution.

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
