Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

SCOPE OF WORK

Scope of Work for Strengthening of Structural Support of Cable Racks/Trays at PHP, RCF Thal

1 General

- 1.1 Bidder should visit site and understand the job before quoting.
- 1.2 Bidder should obtain the necessary work permit for the job & the job is to be started only after obtaining the same. Bidder should also renew the permit

t in every shift.

- 1.3 All possible structural members to be prefabricated before erection in position.
- 1.4 All required drawings will be supplied by RCF engineer in charge.
- 1.5 Bidder should do proper housekeeping of the worksite. This includes the area of fabrication site & erection site. All the metal scrap generated during the job is to be kept at the place instructed by RCF engineer in charge. The transportation for the same is to be arranged by the bidder itself.
- 1.6 All accessories including tools & tackles for welding, Grinding, fabrication & erection are in bidder's scope.
- 1.7 All required consumables like; drill bit, cutting wheel & Grinding wheel, etc. (except those are mentioned in RCF's scope) are in bidder's scope.
- 1.8 Welding shall be such that ingress rainwater in channels will be avoided.
- 1.9 Bidder to follow all safety measure while working at height during erection and welding of platform structures, hand railings etc.
- 1.10 In the event of award of the contract, the bidder shall arrange a movable working platform with a locking wheel arrangement for carrying out the job at a height of up to 4 meters or as per site conditions. The platform shall be certified by the RCF Safety Officer prior to use. After completion of the job, the bidder shall dismantle and remove the platform.
- 1.11 For strengthening of the existing cable tray structure, the work shall be carried out in accordance with the drawing provided below.
- 1.12 The bidder shall cut MS plates of size 300 × 300 × 10 mm and fix these plates at both ends of the existing civil structure using hammer expansion bolts (to be provided by RCF). Using these plates, additional supports shall be provided to the cable racks as per the drawing. The drawing shown here is for illustrative purposes only; the actual size, design, and arrangement may vary as per site conditions.
- 1.13 The industrial gases will be provided by RCF at central stores. The bidder has to bring filled gas cylinders from central stores & return back empty cylinder to central stores immediately.
- 1.14 The repairing work include following activities
 - 1.14.1 Fabrication/Repair of rack as per existing rack.
 - 1.14.2 Replacement of corroded structural supports of cable racks
 - 1.14.3 Strengthening of structural supports of cable racks/trays as per existing or instructed by Engineer in charge.
- 1.15 The Contactor shall ensure that no damage are done to the power cables while carrying out cable rack repair job. These power cables are live, care shall be taken while working on the cable rack/tray, plant machinery and other installations while carrying out the job.
- 1.16 The bidder shall provide minimum one group of per day with Four Skilled (including supervisor) & One Unskilled person/workforce for the job.
- 1.17 Rates remains same including weekly off & Holidays.
- 1.18 Total Job Quantity is not assured & job will be executed as per the availability.

- 1.19 Payment shall be made on actual executed quantity and duly certified by RCF Engineer in Charge.

2 SCOPE OF SUPPLY UNDER RCF

- a) Supply of all structural steels like channel, beams, angles, plates, Pre-Fabricated GI Cable Trays, & GI Earthing Strips.
- b) Welding Electrodes, Oxygen, Acetylene gases as per requirement of the job.
- c) Area will be allotted for prefabrication.
- d) Single point power supply for Grinder & welding machines, etc.

3. SAFETY CLAUSES IN DETAILS

- 3.1 Supervisor appointed must be having experience and qualification for the job to be carried by the bidder.
- 3.2 Workmen's experience, age, address, character need to be certified by the bidder before starting the job.
- 3.3 Safety training from RCF's safety department must be taken by all persons before starting the job.
- 3.4 Following safety appliances must be made available by the party for workmen at Job site:

- 3.5 Safe job procedure has to be submitted by the bidder with consulting, nature of job with concerned engineer.
- 3.6 Supervisor must follow the safety provisions as per safety work permit and strict supervision on the job.
- 3.7 The cutting torch used by the bidder shall have a double gauge regulator & a flash back arrestor.

Tenure of the Contract:-

The work order shall be valid for a period of **ONE year** from the date of issue of work order.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of

bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:
